If the Applicant fails to submit the shipper code under the preceding sentence, POZAGAS a.s. is entitled to postpone commencement of provision of gas storage service by the number of working days of Applicant's delay.								
2.5)	The Applicant hereby confirms that it is entitled to dispose of Gas designated for storage in the Storage Facility pursuant to the Gas Storage Contract.								
2.6)	The Applicant hereby represents, that it is not being wound up and that no bankruptcy or restructuring proceedings or similar proceedings under applicable national legislation have been commenced against it and that no petition requesting that is be declared bankrupt has been dismissed because of insufficient assets.
