The Application submitted within such period constitutes a binding proposal to conclude Gas Storage Contract and/or amendment. The Application commitment period is thirty (30) days from the end of the period for delivery of Applications, if Tender Terms and Conditions or Applicant does not stipulate otherwise. If services are offered on FCFS basis (first come first served), the Application commitment period is thirty (30) days from delivery of an Application if Tender Terms and Conditions or Applicant does not stipulate otherwise.
- 4.6) The Applicant hereby represent that it will submit to POZAGAS no later than three (3) working days prior Nomination submission, a shipper code assigned by relevant Connected Network Operator (valid only in case of services under sections 3.2, 3.3, 3.5 and 3.7 of this Application). If the Applicant fails to submit the shipper code under the preceding sentence, POZAGAS is entitled to postpone commencement of provision of a service by the number of working days of Applicant's delay.
- 4.7) The Applicant hereby confirms that it is entitled to dispose of Gas designated for storage in the Storage Facility within the range of requested service (valid only in case of services under sections 3.1 and 3.7 of this Application).
- 4.8) The Applicant hereby represents that is it not being wound up and that no bankruptcy or restructuring proceedings or similar proceedings under applicable national legislation have been commenced against it and that no petition requesting that it be declared bankrupt has been dismissed because of insufficient assets..
- 4.9) The Applicant hereby represents, if requested service under section 3.6 of this Application, that it will deliver to POZAGAS the Power of attorney to represent Applicant in customs declarations under a form published on www.pozagas.sk on the day of requested start of service utilisation at the latest.
